

RESOLUTION NO. 22-0321

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MAUD, BOWIE COUNTY, TEXAS, CANCELLING THE GENERAL ELECTION SCHEDULED TO BE HELD ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING MAYOR AND THREE COUNCIL SEATS DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MAUD, BOWIE COUNTY TEXAS, THAT:

SECTION 1. The filing deadlines for name placement on the ballot have passed.

SECTION 2. Section 2.053 (a) of the Texas Election Code authorizes the governing body to declare each unopposed candidate elected to their respective office and to cancel the election thereby avoiding the expenses related to holding an election and saving public funds.


SECTION 3. The following candidates, who are unopposed for the May 7, 2022 General Election are hereby declared elected to their respective office and shall be issued a certificate of election:
