
Immediately following Tax Rate Public Hearing

1. Call to order and establish a quorum.
Meeting was called to order. All council members present. A Quorum was established.
2. Invocation and Pledge of Allegiance
Prayer a and pledge led by Mayor Jimmy Clary.


3. Consider and take official action on requested increase by AmeriTex for garbage service costs for the 2022-2023 term of the current contract. – Arnold Bernardino
On behalf of AmeriTex, Mr. Bernardino requested an overall 8% increase due to the cost of fuel and the landfill costs. Motion by Councilwoman Debbie Mathis and 2nd by Councilman Robert Wells to allow only the 5% increase granted in the contract. Motion carried.
4. Consider and take official action on approving authority for the Mayor to negotiate and complete the sale of the property located at 132 / 134 Main Street.
Motion by Councilman Boyd Sartin and 2nd by Councilman Terry Martin to grant the negotiation/completion authority to Mayor Jimmy Clary for the sale of the property located at 132 / 134 Main Street. Motion carried.
5. Consider and take official action on approving Ordinance No. 22-0829B adopting the 2022-2023 fiscal year budget.
Motion by Councilman Boyd Sartin and 2nd by Councilwoman Debbie Mathis to approve Budget Ordinance # 22-0829B. Motion carried.
6. Consider and take official action on approving Ordinance No. 22-0829 setting the City's 2022 Ad Valorem Tax Rate at 0.558264 / \$100 valuation.
Motion by Councilman Robert Wells and 2nd by Councilwoman Debbie Mathis to approve tax Rate Ordinance. Motion carried with Councilman Terry Martin in opposition.
7. Consider and take official action on the City of Maud entering into an Interlocal Agreement for Wastewater System Operations and Maintenance Services with Riverbend Water Resources. – Kyle Dooley appeared in person to answer any questions and to voice his appreciation for the hard work put forth by Maud bringing this project to fruition.
Motion by Councilman Boyd Sartin and 2nd by Councilman Terry Martin to approve the Interlocal agreement with Riverbend. Motion carried.
