Councilman Boyd Sartin nominated Councilwoman Linda Price to serve as Mayor Pro Temp for one year. No other nominations were made. Councilwoman was voted in as Mayor Pro Temp unanimously. On behalf of the staff of the City of Maud, City Secretary welcomed each councilmember and informed them that everyone was looking forward to working with them.

5. Kelly Birdwell, with Wilf & Henderson, P.C. to present the October 1, 2022, to September 30, 2023, FY audited financials.

Ms. Birdwell presented highlights from the audit to the council. She stated that the current staff at city hall were very easy to work with and very knowledgeable as to the needs of the auditor and made the audit process very easy to perform. The city staff was commended on the fact that the

monthly reports supplied to the council were sound, accurate and could be trusted in revealing the city's financial standing. Ms. Birdwell stated that she was very impressed with the Librarian, Savannah Monroe, as she had gone above and beyond what most small city librarians do in searching out, applying for and receiving grants. The grants received in the FY had a very positive impact on the general fund balance. The overall audit report was very encouraging, and the council was commended for their part in making sound financial decisions on the city's behalf.
