Notice is hereby given that the Governing Body of the Maud City Council, Maud, Texas will hold its Regular Council Meeting on September 13, 2024, in the Council Chambers located at 135 Main St., Maud, Texas, for consideration of the following agenda items.

1. Call meeting to order, roll call, establish a quorum.
2. Invocation and pledge of allegiance.
3. Open Forum - Comments from the public, limited to no more than 3 minutes each, and no more than five speakers.
4. Consider and take official action on approving the Consent Agenda – all items are deemed to require minimal council deliberation and can be enacted as one business item.

  - b. August 19, 2024 Regular Council Meeting minutes; and September 3, 2024 Special called meeting minutes;
  - c. August 2024 Departmental Reports
5. Consider and take official action approving the Interlocal Agreement under Government Code Chapter 791, between The City of Maud (Local Government) and The Texas Department of Motor Vehicles (TxDMV) for the implementation of the Vehicle Registration Denial Program, as outlined in the Texas Transportation Code Sec. 702.003 (commonly known as the Scofflaw Program). - John Morris, MVBA
6. Consider and take official action approving the Memorandum of Understanding (MOU), between The City of Maud (City) and McCreary, Veselka, Bragg, and Allen, PC (MVBA). The MOU will authorize MVBA, as a third-party, on behalf of the City, to conduct the Scofflaw Program and provide the funds necessary to post the required bond with the DMV and pay all costs associated with the operation of the program. – John Morris, MVBA
7. Adjourn.

**NOTE: ALL AGENDA ITEMS ARE SUBJECT TO ACTION.** The Council reserves the right to adjourn to executive session on any applicable agenda item pursuant to Title 5, Chapter 551, of the Texas Government Code.

**PUBLIC COMMENT REQUIREMENTS:** Persons desiring to address the City Council regarding an Agenda item must sign up with the City Secretary prior to the beginning of the meeting. Items to be discussed are limited to a time limit of 3 minutes per person, per item. Each speaker must sign in with their name, address, and the agenda item they wish to speak on.

**PUBLIC NOTICE:** to Section 46.035(c), Penal Code (unlawful carrying of handgun by license holder), a license holder commits an offense if the license holder intentionally, knowingly, or recklessly carries a handgun under the authority of Subchapter H, Chapter 411, Government Code, regardless of whether the handgun is concealed or carried in a shoulder or belt holster, in the room or rooms where a meeting of a governmental entity is held and if the meeting is an open meeting subject to Chapter 551, Government Code, and the entity provided notice as required by that chapter.
