Motion by Councilman Boyd Sartin and 2nd by Councilman Robert Wells to approve the tax rate ordinance. Motion carried with no opposition.


5. Consider and take official action approving the acceptance of the Assistance to Firefighters Grant # EMW-2023-FG-00986 in the amount of \$143,819.05.

6. Adjourn.


Motion by Councilman Boyd Sartin and 2nd by Councilman Wayne Foster to adjourn. Meeting was adjourned at 6:13 p.m.
