

## **ORDINANCE NO. 24-0903**

**AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF MAUD, TEXAS REVIEWING AND APPROVING THE RATES TO BE CHARGED FOR UTILITY SERVICES FURNISHED, OWNED AND OPERATED BY THE CITY OF MAUD, TEXAS. REPEALING ALL ORDINANCES, POLICIES, RESOLUTION OR ANY PART THEREOF IN CONFLICT; PROVIDING FOR THE IMMEDIATE PASSAGE OF THIS ORDINANCE BE INVALID SUCH INVALIDITY WILL NOT AFFECT THE REMAINDER OF THIS ORDINANCE; DECLARING AN EMERGENCY; AND PROVIDING AN EFFECTIVE DATE.**

**AN ORDINANCE BEGINNING OCTOBER 1, 2024, AND ENDING SEPTEMBER 30, 2025.**

WHEREAS, the City Council of the City of Maud, Texas ("City") has determined that certain rates for water, sewer and garbage services provided by the City to its residents must be adequate to provide for the debt service of the City's water, sewer, and garbage systems, for the operation and maintenance expenses of the water, sewer, and garbage systems, for the upgrading of the systems, and for the contribution to support implementation of a regional system; and

WHEREAS, it is the desire of the City Council to set forth water, sewer, and garbage rates which are sufficient to provide for payment of all outstanding indebtedness relating to the City's water, sewer and garbage systems, including certain Certificates of Obligation to provide for the operation and maintenance expenses of the water, sewer, and garbage system, to provide funds for upgrading the systems, and to provide support for the implementation of a regional system;

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MAUD, TEXAS:**

Section 1. That the above recitals are true and correct.

Section 2. The rates to be charged for water sewer, and garbage services by the City of Maud, Texas shall be computed in "Exhibit A":

Section 3. This Ordinance and all its sections and rates set forth below will remain in effect until modified by the City Council of the City of Maud, Texas.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed to the extent of such conflict.

Section 5. The fact that the City Council is in immediate need of relief ordered by the provision of the Ordinance creates an emergency and an imperative public necessity, and this Ordinance shall be in full force and effect from and after its passage and approval, and it is so ordained.

**Current Water, Sewer and Garbage rates per "Exhibit A" will be effective beginning October 1, 2024 and ending September 30, 2025.**

**"EXHIBIT A"**

**Water and Sewer Rates are as follows:**

**Water – Residential Inside**

Minimum Charge (0 -2000 gallons)	\$ 32.60
Volumetric Charge (2001 + gallons)	\$ 9.76

**Water – Residential Outside**

Minimum Charge (0 -2000 gallons)	\$ 37.55
Volumetric Charge (2001 + gallons)	\$ 10.25

### **Water – Commercial**

Minimum Charge (0 -2000 gallons)	\$ 40.00
Volumetric Charge (2001 + gallons)	\$ 11.65

### **Sewer – Residential Inside**

Minimum Charge (0 -2000 gallons)	\$ 26.40
Volumetric Charge (2001 + gallons)	\$ 9.76

### **Sewer – Residential Outside**

Minimum Charge (0 -2000 gallons)	\$ 26.97
Volumetric Charge (2001+ gallons)	\$ 10.26

### **Sewer Commercial**

Minimum Charge (0 -2000 gallons)	\$ 38.80
Volumetric Charge (2001 gallons)	\$ 11.65

### **Garbage – Poly cart**

Residential with water	\$ 20.31
Residential Outside Garbage Only	\$ 33.66
Commercial Inside	\$ 27.98

**Additional Poly carts are same price as the first cart &  
Each cart thereafter**




This Ordinance shall be in full force and effective after adoption, beginning October 1, 2024, and ending September 30, 2025, and approved, as provided by law.
