- 6. Consider and take official action approving Ordinance No. 25-0818. AN ORDINANCE OF THE CITY OF MAUD, TEXAS, REPEALING ORDINANCE NO. 25-0616 AND REPLACING REPEALED ORDINANCE WITH THIS ORDINANCE.
