7. Discuss and take action on rerouting city water lines and hooking up a new meter for a house belonging to Jane Nice located on Pecan Street.

Consider and take official action to renew the Mowing Contract for the mowing/weed eating maintenance for specified areas within the City of Maud, (noting the addition of the railroad crossings along Hwy 67 within the city limits) with Kenneth Bailey for \$1,200.00 per mowing (typically, twice monthly).
